# 2019 Transportation Planning Applications Conference

## Registration, Hotel and Travel Assistance Reimbursement Application for Attendees from Public Agencies and Qualifying Students

The 17th TRB National Transportation Planning Applications Conference (2019 TRBAppcon) is offering a limited number of fellowships for conference attendees to facilitate attendance by individuals from public agencies and students in transportation planning related programs who would otherwise not be able to attend the conference. Individuals selected will obtain a code for free early bird registration (must register by April 1, 2019) at a value of up to \$475 and will be reimbursed for travel and hotel expenses at a value of up to \$275. If selected, TRB will contact fellowship recipients to provide the registration code to register by April 1, 2019 and instructions for reimbursement of hotel and travel related expenses to be submitted after the conference. Individuals are responsible for making their own registration with the registration code by April 1, 2019 and for making and paying for their own hotel and travel reservations and complying with the reimbursement instructions.

Then, applications will be processed on a first come first served basis until the allotted number of fellowships are assigned. Assistance will be limited to one award per agency or university. Notification of selection will be sent by March 15, 2019 to allow fellowship recipients to register prior to the early bird registration deadline of April 1, 2019.
